Note – All coaching, team management and club facilities are all kindly provided by un-paid volunteers.

Our cricket festivals require a little more involvement from all participating children’s Parent(s) / Carer(s) / Guardian(s) to make the event enjoyable for all. This normally requires about 2 hours to man a stall.

Section 9 - Data Protection.

The Club will use the information provided on this form (together with other information it obtains about the player) (together 'Information') to administer his/her cricketing activity at the Club and any activities in which they participate through the Club and to care for and supervise activities in which he/she is involved. In some cases this may require the Club to disclose information to the County Boards, Leagues and to the England and Wales Cricket Board. In the event of a medical issue or child protection issue arising, the Club may disclose certain information to doctors or other medical specialists and/or to the Police, children's social care, the Courts and/or probation officers and, potentially to legal and other advisers involved in an investigation.
